

The 2007/2008 ERC Policies and Benefits Survey (PBS) was conducted by The Management Association of Illinois in cooperation with 15 other members of the Employer Association Group (EAG), including ERC. The data for this edition were collected during the fourth quarter of 2006. Participants could participate online or via paper questionnaire, but all data was entered online before processing. A total of 202 Northeast Ohio organizations participated in this edition of the PBS.
